**IAMI Certified Marine Investigator (CMI) Recertification Requirements**  
**Revised (09-16)**

- A. IAMI Member in good standing during past five (5) years as a CMI.
- B. Attendance **a minimum of one (1)** IAMI Annual Training Seminar (24 credit hours).
- C. The applicant must have completed a **minimum** of one hundred (100) credit hours\* of courses in marine investigation, fraud, theft, law enforcement, etc. These credit hours may include credits from any other IAMI Annual (24 credit hours) or Regional Training Seminar ( 8 credits per day) as referenced above or other relevant and related training.
- D. Must be currently employed in the marine, criminology, law enforcement or marine insurance industry.
- E. Submit a completed IAMI CMI RECERTIFICATION APPLICATION along with the \$95.00 application fee to IAMI Headquarters by **July 31st of the 5 year recertification anniversary.**
- F. ***Include supporting documentation of classes attended / credit hours listed on Recertification Application (copies of course diplomas, certificates, etc.)***

**CMI Recertification Applicants:** Attach evidence to support the above listed training was completed. The documentation must include the course taken, the provider, the date the course was completed and the credit hours or other supporting material as available. Return form and documentation with \$95 USD fee **by July 31<sup>st</sup> of the 5<sup>th</sup> year recertification anniversary..**
