1. **LAW ENFORCEMENT (\$40.00 US)**

municipal, county, state, federal, national or international law enforcement agencies who are full time salaried employees with peace officer powers or are engaged in intelligence gathering, United States Coast Guard officials, special agents of the National Insurance Crime Bureau (NICB) and administrative officials of vessel registering or titling authorities may be eligible for Law Enforcement Membership. **New applicants must include a photocopy or current LE Credentials.**

2. **NON-LAW ENFORCEMENT (\$70.00 US)**

Law enforcement officers in reserve, auxiliary or retired status. Private Marine Investigators, Insurance Investigators and Marine Industry Representatives. **New applicants must provide three things: resume, include a photocopy of their current driver's license and/or passport, and provide a copy of recent background check with submission of application.** Upon review of background check, the report and photo ID will be securely shredded.
